The Los Angeles International Airport/Community Noise Roundtable (Roundtable) was formed in 2000 as a follow-on to the work of the Federal Aviation Administration's (FAA) Southern California Task Force. It is based on letters of intent from eight cities, selected members of the Los Angeles City Council, Los Angeles World Airports (LAWA), the County of Los Angeles, a State Assemblyman's office, the FAA Western-Pacific Region, the airline industry, several local community groups and two congressional offices. The position adopted by the Roundtable, as stated in this correspondence, is not the official position of the City of Los Angeles or Los Angeles World Airports. The LAX/Community Noise Roundtable is a voluntary and independent body and this position is the opinion of the majority of the membership.

HR 2107 was introduced by Representative William O. Lipinski, (D, IL) on June 7, 2001. We understand the intent of the author was to provide a mechanism for overriding local and state opposition to the expansion of the Chicago O'Hare International Airport. However, as written and subsequently amended, it could include other major airports such as Los Angeles International Airport.

While this bill would appear to be in a hold status, the members of the Los Angeles International Airport/Community Roundtable are greatly concerned with the intrusion of federal actions into the local decision making process. While we recognize the concerns regarding airport capacity and the national air transportation system, we believe that local adverse impacts could be overlooked by federal intervention in this area. The Roundtable membership believes it is essential that airport capacity decisions be kept at the local level. This would assure that communities adversely impacted by airports have the opportunity to engage in effective mitigation actions based on those local impacts as identified by the citizens.
