Use of AVI Transponder(s) on any vehicle(s) other than the one authorized is a violation of LAX Ground Transportation Rules and Regulations, Section II.2.8.

The company shall pay \$50<sup>1</sup> for each damaged, lost, stolen or unreturned AVI Transponder. Unpaid fees to LAWA may result in the company's inability to receive additional AVI Transponders and Permits until all outstanding accounts have been settled with LAWA.
