## VAN NUYS AIRPORT CITIZENS ADVISORY COUNCIL TUESDAY, FEBRUARY 6, 2018

### 1.) STAFF REPORTS

Ms. Sanchez addressed the council on behalf of Flora Margheritis, who is attending the NBAA conference, as it relates to VNY Statistics: She reported 18,538 aircraft operations in December 2017 and this represents a 20.19% increase in operations compared to December 2016.
