# 1.) STAFF REPORTS

Ms. Margheritis discussed the VNY Air Traffic Control Tower refurbishing project. This project is now complete. The temporary Air Traffic Control Tower is expected to be dismantled in the next month.

Mr. Parseghian stated he is looking forward to his new appointment and talked briefly about his background.
