Daily Taxiway Closures – Taxiway A Shoulder Repaving

Taxiway A will be closed daily for shoulder asphalt repaving over the course of several weeks. This work will be completed in several phases, and the affected segments of Taxiway A will be closed during the daytime work hours for each phase. Please see the closure schedule below and attached exhibit outlining the work areas.

Closure Schedule

Phase 1: Taxiway A closed between Taxiway F and Taxilane A2, Jan. 7th-10th 2019, 0730-1430L. Taxilane A1 apron remains accessible for ADG V and smaller aircraft.

Phase 2: Taxiway A closed between Taxilane A2 and Taxilane A3, Jan. 14th-15th 2019, 0730-1430L. Taxilane A2 and Taxilane A3 aprons remain accessible.

Phase 3A: Taxiway A closed between Taxilane A1 and Taxilane A2, Jan. 28th-31st 2019, 0730-1430L. Taxilane A1 apron will not be accessible for aircraft during the work hours.

Phase 3B: Taxiway A closed between Taxiway F and Taxilane A1, Feb. 11th-13th 2019, 0730-1430L. Taxilane A1 apron will not be accessible for aircraft during the work hours.

Phase 4: Taxiway A closed between Taxiway F and Taxilane A3, Feb. 25th-28th 2019, 0730-1430L. Taxilane A2 apron will not be accessible for aircraft during the work hours.

Phase 5: Taxiway A closed between Taxilane A2 and Taxilane A3, Mar. 4th-6th 2019, 0730-1430L. Taxilane A3 apron access restricted during the work hours.

A Notice to Airmen (NOTAM) will be issued 72 hours prior to the scheduled closures. Please plan your flight operations accordingly. For current airfield operating conditions please check NOTAMs at https://pilotweb.nas.faa.gov. Thank you for your support.


