

### THE DEPARTMENT OF AIRPORTS OF THE CITY OF LOS ANGELES (LOS ANGELES INTERNATIONAL AIRPORT)

#### **Notice Regarding Ratings Change**

The Department of Airports of the City of Los Angeles, California (the "Department"), in compliance with its obligations under the Continuing Disclosure Certificates executed in connection with the issuance of the Department's outstanding (i) senior revenue bonds listed on <u>Exhibit A</u> attached to this Notice (the "Senior Bonds") and (ii) subordinate revenue bonds listed on <u>Exhibit B</u> attached to this Notice (the "Subordinate Bonds", and together with the Senior Bonds, the "Bonds"), hereby provides notice regarding the current status of the ratings with respect to the Bonds.

On October 23, 2018, Moody's Investors Service ("Moody's") upgraded its rating with respect to the (i) Senior Bonds to "Aa2" from "Aa3" and (ii) Subordinate Bonds to "Aa3" from "A1".

On October 23, 2018, Standard & Poor's Ratings Group ("S&P") affirmed its rating with respect to the (i) Senior Bonds at "AA" and (ii) Subordinate Bonds at "AA-".

On October 23, 2018, Fitch Ratings ("Fitch") affirmed its rating with respect to the (i) Senior Bonds at "AA" and (ii) Subordinate Bonds at "AA-".

As a result of such actions and as of the date of this Notice, the Bonds have been assigned the ratings by Moody's, S&P and Fitch, respectively, as shown on <u>Exhibit A</u> and <u>Exhibit B</u> attached to this Notice.
