## DELTA AIRLINES RELOCATION

As everyone has probably heard, the Delta Airlines relocation from Terminal 5 to Terminals 2 and 3 is unprecedented in airline history. Not only will Delta Airlines be affected, but the move will impact approximately 29 smaller air carriers and over 100 ground support services. All companies who will be impacted need to be proactive in their move.

- Note the move is planned for May 12th-17th.
- Know where your staff will be located
- Identify what access will be necessary.
- Be advised that the Security Credential Section will need to have an updated Enrollment packet for any new terminal access necessary. <u>Get the</u> <u>paper work in promptly.</u>
- Special access may not be granted in certain circumstances. Ultimately, it is at the discretion of the Vulnerability Assessment and Analysis Unit (VAAU) of the Airport Police.
- Be aware that the project management is conducted by Chrysalis Aviation Solutions.

We are requiring that the Authorized Signers have Enrollment Packets submitted to you're the company's contract administrator by **April 14th.** 

Companies that fail to submit all of their documentation by April 14th run the risk of not having access in a suitable amount of time.

We can't stress enough the urgency in companies and authorized signers in communicating with each other.

The Los Angeles World Airport (LAWA) Executive Committee has approved a plan to bring the Edge4Vets jobs prep program to LAX! The program will prepare veterans to apply for an airport job that may lead to a full-time civil service career.

In partnership with Los Angeles World Airports, **Edge4Vets** will offer a FREE workshop on April 20th to CONNECT Southern California veterans to job and career opportunities at our aviation partner companies.

At the Connect Workshop, HR Reps from our airport partner companies will show veterans how to match their SKILLS and INTERESTS to job and career openings at airport companies, including LAWA, airline carriers, airport service companies (in security, retail, concessions) and more.

Also, the veterans will be contacted personally to show them how they can prepare for the workshop by learning how to translate their military skills into tools for civilian success – for an "edge" with airport employers who attend the workshop looking to hire talented veterans.
