El Segundo Dunes Rehabilitation Area

On January 10, the California Coastal Commission approved LAWA's permit application to improve the visual appearance and to plant native vegetation in the ecologically important El Segundo Dunes area west of LAX.

The Dunes Improvement Project includes the removal of selected abandoned streets, curbs, gutters, sidewalks, retaining walls, foundations, and above-ground utilities. The Board of Airport Commissioners authorized to put the work out to bid on February 19.

The project also includes the reduction of non-native invasive plants and the planting of approximately six acres of native coastal dune and coastal prairie vegetation spread out within a 48-acre area that was formerly a residential subdivision.

Final Environmental Impact Report (EIR) Completed

The LAX Specific Plan Amendment Study (SPAS) Final Environmental Impact Report (EIR) was completed and released by LAWA on January 25. The report includes written responses to comments submitted during the official public review period of the draft version, revisions, and other final EIR materials. LAX Specific Plan Amendment Study (SPAS) Update

The City of Los Angeles Department of City Planning hosted an Open House/Public Hearing on proposed amendments to the LAX Plan, LAX Specific Plan, and related General Plan Elements on January 8 at the Proud Bird Restaurant.

LAWA is conducting a Specific Plan Amendment Study (SPAS) in accordance with the LAX Specific Plan and the LAX Master Plan Stipulated Settlement. The SPAS identified and evaluated nine potential alternatives to certain components of the LAX Master Plan, referred to as Yellow Light Projects, including various configurations for the north airfield, terminal improvements, and LAX's ground transportation system.

No decision was made at the Open House. On January 31, the Board of Airport Commissioners (BOAC) held a special session for the public. On February 5, the BOAC approved the Environmental Impact Report for the LAX SPAS, including the Final LAX SPAS Report, the Staff-Recommended Alternative; and amendments to the LAX Plan and LAX Specific Plan.

A decision on SPAS by the BOAC is subject to review and approval by other local decision-making bodies including, but not limited to, the Los Angeles City Council. To learn about the SPAS, please visit www.laxspas.org.

LAX CAPITAL IMPROVEMENTS

Tom Bradley Int'l Terminal Entryway Facelift



In December 2012, the pedestrian bridge connecting Parking Structure 4 and Tom Bradley International Terminal (TBIT) was removed as part of the "New Face of the Central Terminal Area (CTA)" project. The old glass/steel canopies were removed at the entrance to TBIT and construction is underway on the new modern canopies that will completely change the appearance of TBIT's entryway. The planters along the edge of the second level roadway are also being removed to make way for a new light band that will eventually stretch around the entire Central Terminal Area. The New Tom Bradley Int'l Terminal

In November 2010, the first pieces of steel were erected for the new Tom Bradley International Terminal (TBIT). Exactly two years later, the exterior of the new facility is almost complete. Gate 134 is in use and two more, Gates 130 and

132, will be operational in February. The exterior of the entire building is nearing completion and much of the construction is focused on interior work including new concession and lounge areas.

Once completed, there will be approximately 72,000 square feet of new concessions and 97,000 square feet of premier lounge space. New extremely-large baggage carousels capable of handling a high volume of luggage carried by international passengers arriving on A380 aircraft, have been installed. The scaffolding that took up much of the Great Hall has been removed now that the fire/life safety system and ceiling wraps are in place.
