GUEST SPEAKER

David Chan - Noise Management Section, gave an overview of the LAWA Noise Portal which can be found at: <u>https://noiseportal.lawa.org/LAWA</u> The new website was launched August 31, 2020 and contains information that allows visitors on the site to review flight information and noise levels for take offs and landings at LAX. Information can be extracted from specific neighborhoods within the flight path and can be tracked by runway, airline or time of day. The site is interactive and can provide additional detail and video in some cases. People can submit noise complaints and other feedback to LAWA. Request for additional data can also be submitted, but they must be in writing.

There was a discussion regarding the flight plans of pilots who turn early causing increased noise to residents within the flight path. A suggested remedy would be to encourage pilots and airlines to minimize those turns.

Staff mentioned that these type of concerns should be addressed at the Noise Roundtable Meeting which is scheduled for Wednesday, September 16, 2020 at 1:00 p.m.

OFFICER'S REPORT

Chairman Lucero thanked LAWA Staff for providing updates on passenger traffic.

MANAGEMENT REPORT

LAWA staff member C. Espinosa provided updates from CEO Justin Erbacci regarding the increase in travel for the Labor Day Holiday. 75% of the concrete for the Intermodal Transportation Facility has been poured, or almost 70,000 cubic yards. Photos of the LAX Automated People Mover (APM) train cars are now online for the public to view. G. Pacheco provided an update on LAWA Travel Survey. numbers and activity. A. Imamura mentioned that there have been updates on the LAMP construction projects and will invite Stephanie Sampson to address the Committee at a future meeting. LAWA issued a Travel Survey and the results are pending.

G. Pacheco will provide all members with an updated LAXAAC Roster as well as information about the upcoming Noise Roundtable Meeting.

Because of the Guest Speaker and the lengthy discussion, other agenda items were tabled. The meeting was adjourned at 5:03 p.m.
