## **Proposed Revision:**

Administrative Requirements – A set of administrative policies and forms included in solicitation documents, such as Requests for Proposals, to ensure that contractors are aware of and comply with established requirements to perform work for LAWA. To comply with established requirements to perform work for LAWA.

To comply with administrative requirements, contractors must complete and submit specified documents, while other administrative requirements are incorporated as contract provisions. The details of any administrative requirements are set forth in the applicable solicitation document and resulting contract.

training, and exposure to union apprenticeship programs.

LAWA's HireLAX Apprenticeship Readiness Program is an example of an Apprenticeship Readiness Program, in addition to similar programs at local community colleges and other community organizations.

Apprenticeship Readiness Program — a structured apprenticeship training program, generally eight to ten-weeks, that prepares unskilled individuals for a career in construction through an introduction to construction math fundamentals, how to read blueprints, labor studies, hands-on construction, safety training and exposure to union apprenticeship programs.

<u>BOAC</u> – Acronym for the "Board of Airport Commissioners;" a seven-member board appointed by the Mayor of the City of Los Angeles, that governs, provides oversight for, and creates policies on behalf of LAWA.

Business Enterprise <u>Program:</u> BE<u>or BEP (interchangeably)</u> seeks to provide firms equal opportunity to participate in the performance of all LAWA contracts <u>through certification process that identifies those businesses that are traditionally underrepresented</u>

The <u>business enterprise program</u> certifications acknowledged by LAWA\_include the following: Airport Concessions Disadvantaged Business Enterprise (ACDBE), Disadvantaged Business Enterprises Program (DBE), Disabled Veteran Business Enterprise Program (DVBE), Local Business Enterprise Program (LBE), Small Business Enterprise Program (SBE) and Small and Local Business Program (SLB). <u>In addition to the named certifications above, LAWA contracts often require a specified level of participation by firms holding dual certifications in both the LBE & SBE Programs. These are referred to as Local, Small Business Enterprises (LSBE).</u>

These certification programs sometimes are referred to collectively as "XBE" programs and the firms holding business enterprise program certifications sometimes are referred to collectively as "certified firms."

Business Enterprise ("BE") Programs — LAWA's programs that seeks to provide Certified Firms equal opportunity to participate in the performance of all LAWA contracts.

**Business** Enterprise Goal — Percentage of contract value that must be spent with SBE, LBE, LSBE, or DVBE firms, as determined by PSD in the RFP.

## **Proposed Revision:**

BE Program Participation Requirement— The Percentage of the overall contract value that must be spent with businesses holding certifications with LAWA's recognized business enterprise programs. BEP Participation Requirements determined by **LAWA** are or voluntarily pledged by a proposer if LAWA has not set a minimum requirement These requirements are monitored and enforced pursuant to LAWA's BE programs. These requirements sometimes are referred to as "BE goals".

## **Boilerplate Revision:**

BE Program Participation Requirement - The minimum percentage of the overall awarded contract value that must be spent with a Certified Firm, as determined by LAWA's Procurement Services Department (PSD), and pursuant to LAWA's BE Programs.

**BE Pledge** – Percentage of contract value that the Proposer commits to spend with SBE, LBE, LSBE, or DVBE Firms.

**BE Pledge** – The percentage of the overall contract value that the Proposer commits to spend with a business certified pursuant to LAWA's BE program, including the following: Airport Concessions Disadvantaged Business Enterprise (ACDBE), Disadvantaged Business Enterprises Program (DBE), Disabled Veteran Business Enterprise Program (DVBE), Local Business Enterprise Program (LBE), Local Small Business Enterprise Program (LSBE), Small Business Enterprise Program (SBE) and Small and Local Business Program (SLB). These certification programs sometimes are referred to collectively as "XBE" programs.

**BJSR** – Acronym for Business Jobs and Social Responsibility, a LAWA division which seeks to maximize access to business and job opportunities, ensuring that local and diverse communities benefit from LAWA's investments, and to set the global airport standard for public corporate social responsibility.

BJSR – The acronym for LAWA's "Business, Jobs, and Social Responsibility" division, a division that seeks to maximize LAWA's investment in local communities, and advance LAWA's public corporate social responsibility commitments to diversity, equity, and inclusion, by promoting equitable access to business and job opportunities at LAWA for local and disadvantaged businesses and residents.

**B2GNow!** – Acronym for Business to Government Now!; an online database application that tracks Business Enterprise Program goals and requirements, Subcontractor Payment Verification, Subcontractor Utilization Plans, and Prompt Payment to subcontractors. Compliance of the utilization of the system is monitored by LAWA PSD.

## **Proposed Revision:**

**B2GNow!** – Brand acronym for "Business to Government Now!;" a cloud based hosted Software as a Service (SaaS) that streamlines and automates datagathering, tracking, reporting, vendor management, and administrative processes for public sector and other supplier diversity programs. In 2019 LAWA adopted B2Gnow as the system on which contractors are required to report payments to subcontractors and suppliers. LAWA uses this system to monitor Business Enterprise Program achievement, monitor Prompt Payment to subcontractors, and verify subcontractor payments. LAWA's Procurement Services Division (PSD) administers LAWA's B2Gnow! System.

Certified Firms — a term used to refer to the small, local business and other recognized as a part of LAWA's Business Enterprise (BE) program, which includes the following recognized certifications: Airport Concessions Disadvantaged Business Enterprise (ACDBE), Disadvantaged Business Enterprises Program (DBE), Disabled Veteran Business Enterprise Program (DVBE), Local Business Enterprise Program (LBE), Local Small Business Enterprise Program (SBE), Small Business Enterprise Program (SBE) and Small and Local Business Program (SLB). These certification programs sometimes are referred to collectively as "XBE" programs.

Certified Firms – The firms certified in categories designated as Small Business Enterprise (SBE), Local Business Enterprise (LBE), Local Small Business Enterprise (LSBE), and/or Disabled Veteran Business Enterprise (DVBE) as a part of LAWA's BE Program.

Contracts where the provisions of this article would conflict with federal or state grant funded contracts, or conflict with the terms of the grant or subvention, as determined by the DAA, are exempt.

#### **Proposed Revision:**

**Contract** — any agreement, franchise, lease or concession, including agreements for any occasional professional, technical or other service to be provided by a contractor or vendor to LAWA and/or one of its divisions, departments, or units, for the performance of any work or service, the provision of any materials or supplies, or the rendition of any service on behalf of LAWA and/or to the City of Los Angeles and/or to the public, which is let, awarded or entered into with, or on behalf of, LAWA and/or the City of Los Angeles or any Awarding Authority thereof. Contracts where the provisions of this article would conflict with federal or state grant-funded contracts, or conflict with the terms of the grant or subvention, as determined by the DAA, are exempt.

#### Boilerplate Revision:

Contract – The final executed agreement that the City of Los Angeles and/or LAWA enters into with the Selected Proposer or any person, firm, corporation, partnership, joint venture, or any combination thereof.

**Employment Practices** – Any policies, documents and/or other information that reflects a proposer/bidder's or contractor/vendor's policies, procedures, practices and protocols with respect to compliance with federal, state and local employment laws, including issues relating to the recruitment and hiring

of employees; discipline, suspension and termination of an employee; wage and hour practices, including employee compensation; vacation, sick leave and paid time off; training for apprenticeship and other programs; employee benefits; promotions and transfer opportunities.

**Inclusivity** – **Inclusivity** /**Inclusion** /**Reflectivity:** Intentional actions and policies to mitigate barriers and include people who might otherwise be excluded or marginalized from LAWA business and workforce opportunities, as well as to ensure that those who are included are reflective of the wider community composition.

#### **Proposed Revision:**

Inclusivity/Inclusion— These terms, used interchangeably, in the context of business, contracting, workforce, and other opportunities at LAWA, the term refers to LAWA's efforts to ensure that individuals who qualify as local and disadvantaged workers based on LAWA's designated geographic impact zones, and businesses that qualify as local, small, and disadvantaged based on LAWA's Business Enterprise Programs, have the opportunity to participate in LAWA contracting, employment, and other opportunities and programs that are designated for local and disadvantaged workers and businesses.

The business certifications included within LAWA's BE Program include the following: Airport Concessions Disadvantaged Business Enterprise (ACDBE), Disadvantaged Business Enterprises Program (DBE), Disabled Veteran Business Enterprise Program (DVBE), Local Business Enterprise Program (LBE), Local Small Business Enterprise Program (LSBE), Small Business Enterprise Program (SBE) and Small and Local Business Program (SLB). These certification programs sometimes are referred to collectively as "XBE" programs.

**LBPP** – Acronym for Local Business Preference Program; a program designed for the procurement of goods, equipment, and non-professional services, including design and construction, to encourage businesses to compete for LAWA contracting opportunities, to locate operations and create jobs in the City and to encourage existing local business to refrain from relocating.

#### **Proposed Revision:**

**LBPP** – Acronym for Local Business Preference Program; a program designed for the procurement of goods, equipment, and non-professional services, including design and construction, to encourage businesses to compete for LAWA contracting opportunities, to locate operations and create jobs in the City and to encourage existing local business to refrain from relocating.

The LBPP applies to the procurement of goods, equipment, and services, including design and construction, when the contract involves expenditures in excess of \$150,000.

The LBPP does not apply to Bids/Proposals that are subject to a mandatory LBE goal, and where the funding source for the contract is not entirely within LAWA's control.

Each LAWA contract or procurement opportunity in excess of \$150,000 will be reviewed for LSBE subcontracting opportunities. The mandatory participation level will be indicated in the bid/proposal packet.

**LABAVN** – Acronym for Los Angeles Business Assistance Network; a City of Los Angeles centralized online database where firms can register to receive notice of all City competitive opportunities such as bids and RFPs.

Minority – defined to mean "minority person" as the phrase is defined in Subsection (f) of Section 2000 of the California Public Contract Code, as amended from time to time.

Prime – a firm/contractor doing business directly with LAWA

**Prime Contractor/Developer** – The main contractor that submits a bid for and wins the contract award to perform project work and is subsequently responsible for the day-to-day oversight of a construction site, management of subcontractors and suppliers, and the communication with all involved parties throughout the course of building the project.
