Romaine Empire, Inc., d/b/a Farmer's Fridge ("Farmer's Fridge") has been contracted by **URW Airports, LLC** ("URW"). The contract numbers between **Farmer's Fridge** and **URW** are **T1_VMA07_Farmer's** and **TBIT_T40A_VMC01_VM37_Farmer's**. Contract **T1_VMA07_Farmer's** began on **June 22, 2021** and contract **TBIT_T40A_VMC01_VM37_Farmer's** began on **June 23, 2021**. Both contracts will terminate on **June 30, 2023**.

We will provide food concessions in the form of vending machine units. The duties to be performed are as follows:

Tools/equipment **will** be used to fulfill contractual obligations, therefore, vehicle access to the airfield **is** required. Vehicles **are** street licensed.

We **will** be required to obtain a Motor Vehicle Operating Permit (MVOP) to perform the duties of this contract. Our certified trainer is **Juan Castillo, Assistant General Manager at 3869-1: URW AIRPORTS LLC: UNIBAIL RODAMCO WESTFIELD, at juan.castillo@urw.com.**

Job titles for our employees include **Distribution Manager, Distribution Supervisor, Delivery Driver.** We are requesting **5** initial badges and will communicate the need for additional badges in the future.

We **will not** have a written agreement(s) with other company(ies) to share and/or operate each other's equipment and/or vehicles to provide contracted services at LAX.

Estimated Annual Gross Revenue from the contract services provided is **\$700,000.**
