VAN NUYS AIRPORT CITIZENS ADVISORY COUNCIL Tuesday, May 6, 2014 MINUTES

A meeting of the Van Nuys Airport Citizens Advisory Council (CAC) was called to order at 7:10 p.m. by Elliot Sanders. The minutes from the April 1, 2014 meeting were unanimously approved.

1.) STAFF REPORTS

Ms. Margheritis stated Mr. Romo was unable to attend this night's meeting and she will update the CAC in his absence.

Ms. Margheritis stated the June 2, 2014 BOAC Meeting will be held at Van Nuys City Hall at 10:30 a.m. On the agenda they expect the lease amendment for the Pacific Aviation Development lease and the U.S. Customs reimbursable agreement between LAWA and Signature Flight Support. She also stated the MOA between LAWA and Customs will go to the BOAC later this year.
