DRAFT ENVIRONMENTAL IMPACT REPORT FOR LAX SPECIFIC PLAN AMENDMENT STUDY (SPAS)

THE FOLLOWING IS A NOTICE OF AVAILABILITY FOR THE DRAFT ENVIRONMENTAL IMPACT REPORT (EIR) FOR THE SPECIFIC PLAN AMENDMENT STUDY (SPAS), AT LOS ANGELES INTERNATIONAL AIRPORT (LAX) AND NOTIFICATION OF RELATED PUBLIC MEETINGS.

PROJECT LOCATION AND DESCRIPTION: LAWA has prepared a program-level Draft Environmental Impact Report (Draft EIR) for the Los Angeles International Airport (LAX) Specific Plan Amendment Study (SPAS), pursuant to the California Environmental Quality Act (CEQA). The SPAS serves to identify and evaluate potential alternatives to certain components of the LAX Master Plan program, referred to as the Yellow Light Projects. The nine SPAS alternatives include offering various options to the Yellow Light Projects, including one alternative that provides for implementation of all the Yellow Light Projects, one alternative that proposes none of the Yellow Light Projects, and seven alternatives that propose various options to the Yellow Light Projects.

SIGNIFICANT IMPACTS ASSOCIATED WITH THE PROJECT: Implementation of the SPAS Project, depending upon the alternative selected and approved, if any, is expected to result in significant and unavoidable impacts to on- and off-airport transportation, air quality, greenhouse gases, human health risk, land use, aircraft noise, construction equipment noise, combined noise, and solid waste. Impacts to biological resources, coastal resources, cultural resources, hydrology/water quality, transit noise and vibration, and law enforcement services would be less than significant with mitigation. The project study area includes sites enumerated under Section 65962.5 of the Government Code, which are addressed in the Draft EIR.

PUBLIC REVIEW AND COMMENT: LAWA will release the SPAS Project Draft EIR for public review by July 27, 2012, and it will be available for review and comments until 5:00 p.m. on October 10, 2012.
