Pursuant to L.A.M.C. Section 17.03, a Vesting Tentative Tract Map to permit the merger and ACTION:

resubdivision of five lots into 58 lots for future development.

The City Planning Commission Hearing Officer will consider:

Pursuant to L.A.M.C. Section 11.5.7, a Specific Plan Amendment to modify the Los Angeles International Airport (LAX) Specific Plan, to establish new regulations under "Section 11 LAX Northside Sub-Area", including, among other things, a reduction of the maximum buildable area from 4,500,000 to 2,320,000 square feet, and updating the LAX Northside Design Guidelines and Standards.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations. After the hearing, the Hearing Officer will prepare a report, including a recommendation, which will be considered by the City Planning Commission at a later date.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES**: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
