GENERAL INFORMATION ABOUT THIS DOCUMENT

WHAT'S IN THIS DOCUMENT? This document contains a Draft Environmental Assessment (EA) for the Los Angeles World Airports (LAWA) proposed Runway 6L-24R and Runway 6R-24L Runway Safety Areas (RSA) and Associated Improvements Project (Proposed Action), which includes improvements to the RSAs of Runway 6L-24R and Runway 6R-24L and pavement reconstruction of the eastern portion of Runway 6L-24R and Taxiway AA at Los Angeles International Airport (LAX). This document discloses the analysis and findings of the potential impacts associated with the City of Los Angeles proposal, the No Action Alternative, and other reasonable alternatives.

BACKGROUND. *The Transportation, Treasury, Housing and Urban Development, the Judiciary, the District of Columbia, and Independent Agencies Appropriations Act, 2006* (Public Law [P.L.] 109-115), requires completion of Runway Safety Area improvements by airports in the United States that hold a certificate issued by the FAA, under Title 49 of the *United States Code*, Section 44706, to meet FAA airport design standards for RSA required by Title 14, Code of Federal Regulations, Part 139 by December 31, 2015. The City of Los Angeles, as owner and operator of Los Angeles International Airport, has developed its Proposed Action to meet the requirements of P.L. 109-115 for Runway 6L-24R and has proposed improvements that can be implemented by the December 31, 2015 deadline for Runway 6R-24L.

WHAT SHOULD YOU DO? Read this Draft EA and provide comments, if applicable. Copies of this document are available for review at libraries in Los Angeles and other communities around LAX; the Federal Aviation Administration (FAA) office in Hawthorne, California; and the LAWA administrative offices.
