

## LAX Terminal 2 and 3 Modernization Project

## Notice of Public Hearing and Availability of a Final Environmental Impact Report

The City of Los Angeles, Los Angeles World Airports (LAWA), in accordance with the provisions of the Los Angeles International Airport (LAX) Specific Plan (Ordinance No. 182542 Section 7 F.3 (b) Notice of Requirements for the Board of Airport Commissioners is providing this notice of a Board of Airport Commissioners Public Hearing for the LAX Terminal 2 and 3 Modernization Project. In addition, LAWA intends to submit for certification (under CEQA) of the Final EIR for proposed Project. The Final EIR is available online at <u>www.ourlax.org</u>.

**Project Description:** The project proposes to modernize the existing Terminal 2 and Terminal 3 at LAX located within the City of Los Angeles on LAWA property. The proposed project would improve safety and security, passenger convenience, quality of service, and building and operational efficiencies through the renovation of aging terminal facilities. The proposed project would provide approximately 832,000 square feet of new building space that would be added to the two terminals, for a total square footage of approximately 1,620,010 square feet.
