

NOTICE OF FINAL EIR & BOARD OF AIRPORT COMMISSIONERS PUBLIC HEARING

LAX United Airlines East Aircraft Maintenance and Ground Support Equipment Project

The City of Los Angeles, Los Angeles World Airports (LAWA), has prepared a Final Environmental Impact Report (Final EIR) and Executive Director's Report for the Los Angeles International Airport (LAX) United Airlines (UAL) Aircraft Maintenance and Ground Support Equipment (GSE) Project. Pursuant to the California Environmental Quality Act (CEQA) and the LAX Specific Plan (Ordinance No. 185,164), LAWA intends to submit for certification and approval the Final EIR and Executive Directors Report for the proposed project.

PROJECT DESCRIPTION:

The proposed project would consolidate and modernize existing UAL aircraft and GSE maintenance facilities at LAX to allow for more efficient and effective maintenance of existing aircraft and GSE at the airport. Currently, UAL performs maintenance in two areas at LAX: West Maintenance Facility and East Maintenance Facility. The West Maintenance Facility is located in the western portion of LAX, south of World Way West and east of Pershing Drive, and the East Maintenance Facility is located south of Century Boulevard and east of Sepulveda Boulevard. UAL proposes to redevelop their existing eastern facility to consolidate all of UAL's aircraft and GSE maintenance activities. The proposed project would redevelop an approximately 35-acre site currently used for UAL aircraft and GSE maintenance in the eastern portion of the airport with a new 411,000 square foot maintenance facility. The project site currently consists of two maintenance hangars, adjacent paved aircraft apron areas, and surface parking lots. All the buildings on the project site would be demolished, with the exception of a Quonset Hut, which is being relocated by LAWA independently of the project.
