Central Terminal Area (CTA) Parking

- **Airline Relocation** – With the success of the Airline Shuffle, occupancy levels in parking structures P2A and P2B have increased due to the Delta move. Please be prepared to park in other structures when lots have reached full capacity. Parking Garage occupancy levels can be viewed [here](#).
- **Facility Improvements** - CTA Parking Structures are currently undergoing the following facility enhancements:
 - Roof Weatherproofing: Structures P1 & P3 rooftop have been completed, P6 rooftop is still in progress
 - Elevator Upgrades: Structures P1, P3-P7 are expected to receive a number of upgrades through July 28th, 2017.




Reminders

- **Summer Time** – Please allow ample time for parking, shuttle boarding, and travel to the CTA. Summer 2017 passenger levels are projected to be at an all-time high -- 25.6 million guests, a 2.7% increase from 2016.
- **No Cheat Days!** Cheating of any kind is not tolerated for the Employee Access Card system and Employee Parking Pass (EPP) program. If employees are discovered to be sharing with others, they will be removed from the program.
- **Motorcycle Parking** – Motorcycles should not block access to: automobile traffic, doors, driveways, elevators, pedestrian walkways, parking stalls, parked vehicles, handicapped spaces/paths, and entry/exit lanes. Violators will be cited.

Employee Parking & Shuttle Service

- **Shuttle Service Enhancement** – For the summer peak, additional service hours for the Employee and Green Line shuttle service will go into effect July 1st. The G-Bus service has been adjusted for early morning hours to coincide with the Metro Green Line schedule.
- **Employee Parking Options** - LAX employees may use Parking Garage “F” as an alternative parking option. The monthly parking rate is \$75.00 per month. No shuttle service is provided from this parking garage.
- **Airline Connector's New Look** – Be on the lookout for the new bus wrap the Airline Connector shuttles are sporting!
