Stephanie Sampson, Director of Communications – Landside Access Modernization Program (LAMP) & LA Gateways Partners, Consolidated Rent-A-Car (CONRAC) facility

- PCL overview of project ConRAC
 The ConRAC will bring existing rental car operations together into one conveniently located facility adjacent to the 405 freeway with direct connection to the Automated People Mover (APM) train.LA Gateways has a partnership with LAWA to design, build and operation and maintain. PCL is the design constructors of the project
- By the Numbers
 \$1 Billion construction contract value
 Create 1,000 construction jobs
 Approximately 5.3 million sq ft facility
 3,200 daily rental car shuttle trips eliminated from Central Terminal Area
 (CTA) and approximately 18,000 total parking spaces
 7 cranes total- first 2 by February 2020
- Quick Turn Around (QTA) Facilities The QTA allows for car washing, fueling and light maintenance Will be the largest gas station in the US.
- Sustainable design Native drought tolerant landscaping LEED silver certification Solar Farm generating over 8,400 Megawatt hours annually -solar panels will be installed on the roofs of the CONRAC LAWA will plant more trees**
- Financing The CONRAC will be built using a private public partnership (P3) contracting model

LA gateway partners will be designing, constructing and financing the project and will also be responsible for operating and maintaining it for a 28-year period.

Onsite Batch Plant

"Operational Ready: by Thanksgiving 2019 Primarily serves the Ready/Return/Idle Storage (220,000 CY of concrete) Hours of operation: early afternoon until the afternoon There will be trainings to operate the building

1,000 CY of concrete a day, 3 to 4 days per week, consistently for 1.5 years Provide reliable concrete delivery Reduces the number of trucks (80-90 fewer trucks daily)

- LA Gateway partners over 10 different companies and organizations Business Inclusion PCL is very involved in business inclusion and one of their key focuses There are contractual goals that must be met but PCL considers it their baseline to have business inclusion
- Workforce Development local hiring Small Business Enterprise (SBE) – 22% Local Business Enterprise (LBE) – 20% Local Small Business Enterprise (LSBE) – 5% Disable Veteran Business Enterprise (DVBE) – 5%
- PCL is very familiar with the rules that are needed for local hiring
- Have been approved by Dept of Cultural Affairs for a rendering on the building -south side of the ready to return and front door of the CONRAC
- This initiative is a team effort and looking to engage in all aspects
- There are project milestones
- Final completion is expected to be July 31, 2023
