Catalina Saldivar-Chavez LAWA Environmental Division

Catalina provided an update on the Sound Installation Program. The Noise Compatibility Program was funded by LAWA and the FAA for the installation of sound insulation for residents and schools in four jurisdictions affected by the airport, the program ran 1997-2014 and included 7,000 units. The City of Inglewood's program is ongoing with approximately 7,000 units. The City of El Segundo suspended their program in 2017 and maintains eligible properties. The County of Los Angeles' program is ongoing and has insulated approximately 4,000 units. Los Angeles World Airports has no set eligible funds for future insulation; however LAWA will match 20 percent of any FAA funds secured by the jurisdictions for the future installation on eligible properties. Catalina also provided information regarding the changes to the FAA guidelines and requirements in 2017 to determine eligible properties.
