Note: All applicants who fall under one of these categories (affected countries) must present the following when they come to the Badge Office for processing: (Originals and Copies of all documents must be presented)

1. Employment Authorization Document (EAD) 2. Receipt indicating re-registration date 3. All required Fingerprinting/Badge-related applications

Note: Applicants who have applied during the re-registration period and who have not received the new EAD are eligible for the 180-day extension and will be processed with a short-date badge, not to exceed the EAD Auto Extension for that country (see above).

Note: Applicants who have NOT re-registered may receive a short-date badge not to exceed the re-registration period date for that country (see above).
