Bradley West Ground Breaking Ceremony

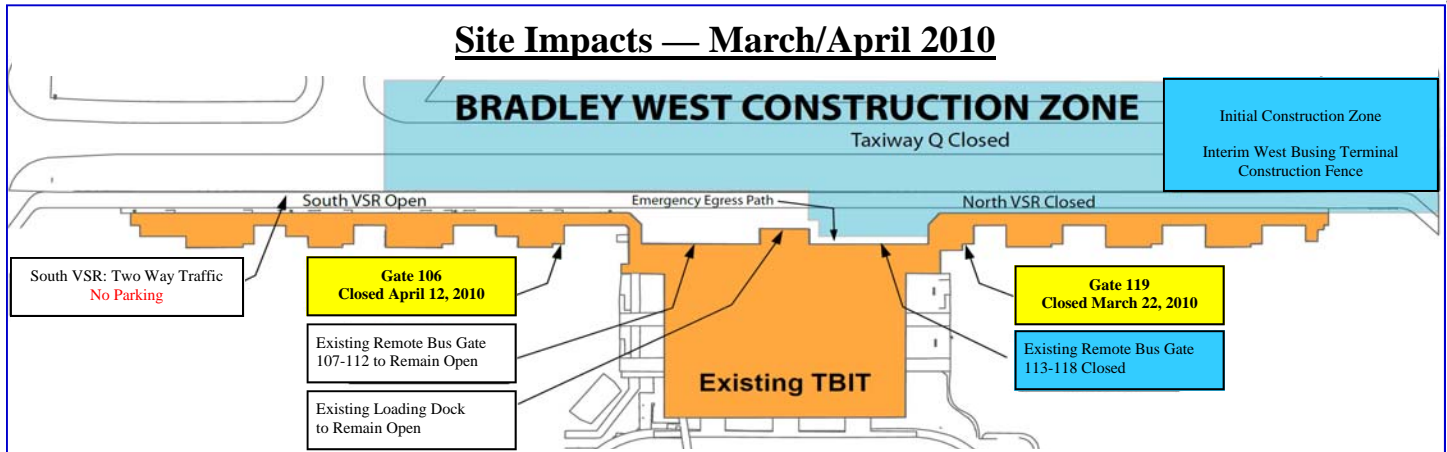


Los Angeles Mayor Antonio R. Villaraigosa, City Council members, airport commissioners and 400 airline/airport officials attended the Bradley West Project Ground-Breaking Ceremony on Monday, February 22, 2010 at Tom Bradley International Terminal at Los Angeles International Airport.

The North Vehicle Service Road and Remote Bus Gates 113 - 118 have been closed and the South Vehicle Service Road has reverted back to two way traffic.

Gate 119 is scheduled to be closed Monday March 22, 2010 for approximately 5 months and Gate 106 is scheduled to be closed Monday April 12, 2010 for approximately 8 months.

The gate closures are required for major utility upgrade/construction. The utility work includes tunnel construction where hydraulic jacks are used to push pipes through the ground behind a tunnel boring machine.

Every effort shall be made to accelerate the construction schedule and minimize the closures of Gates 106 and 119.

Bradley West Project Goes GREEN

The Bradley West Project has set a design objective for LEED Silver Certification. The Leadership in Energy and Environmental Design (LEED) Green Building Rating System encourages and accelerates global adoption of sustainable green building and development practices through the creation and implementation of universally understood and accepted tools and performance criteria. Developed by the U.S. Green Building Council (USGBC), LEED provides building owners and operators a concise framework for identifying and implementing practical and measurable green building design, construction, operations and maintenance solutions. LEED is a third-party certification program and the nationally accepted benchmark for the design, construction and operation of high performance green buildings. LEED gives building owners and operators the tools they need to have an immediate and measurable impact on their buildings' performance. LEED promotes a whole-building approach to sustainability by recognizing performance in five key areas of human and environmental health: sustainable site development, water savings, energy efficiency, materials selection and indoor environmental quality.

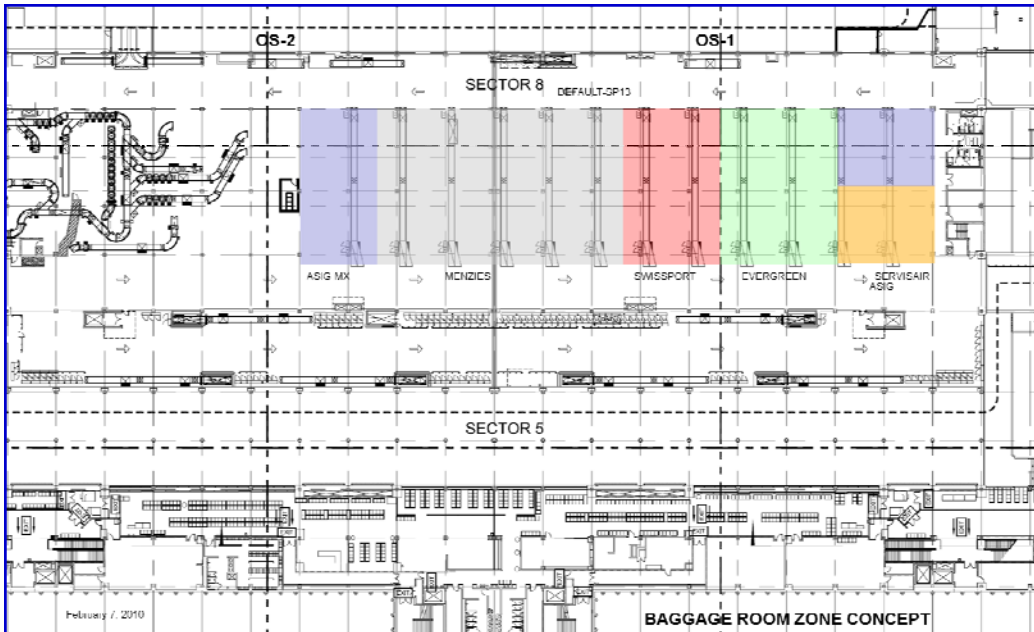
LEED-certified buildings are designed to:

- Lower operating costs and increase asset value
- Reduce waste sent to landfills
- Conserve energy and water.
- Be healthier and safer for occupants
- Reduce harmful greenhouse gas emissions.
- Qualify for tax rebates, zoning allowances and other incentives in hundreds of cities.
- Demonstrate an owner's commitment to environmental stewardship and social responsibility.

Baggage Area Zone Concept Test



LAXTEC has been working closely with LAWA Terminal Operations, TBIT airlines, ground handling companies, and service providers to develop a path forward toward a “zone” concept for the TBIT baggage area. The result of that effort by all parties is an agreement to “test” the zone concept for the remaining part of the Winter Schedule, March 1 to March 27.

The zone concept is an effort to give the ground handlers and their airline clients more stability for sort pier assignments, more responsibility for a portion of the baggage room, and greater flexibility in staging flights without impacting other ground handlers. In order for this concept to work, the airline and ground handler community must work together to eliminate the requests for sort

pier assignment changes and stick with the “plan”. The airlines must work with the ground handler on how best to set up and work your flights within the assigned zone. The test period will be monitored closely, and any problems will be resolved by the community prior to the change to the Summer Schedule on March 28. Thank you for your cooperation and support as we move forward.

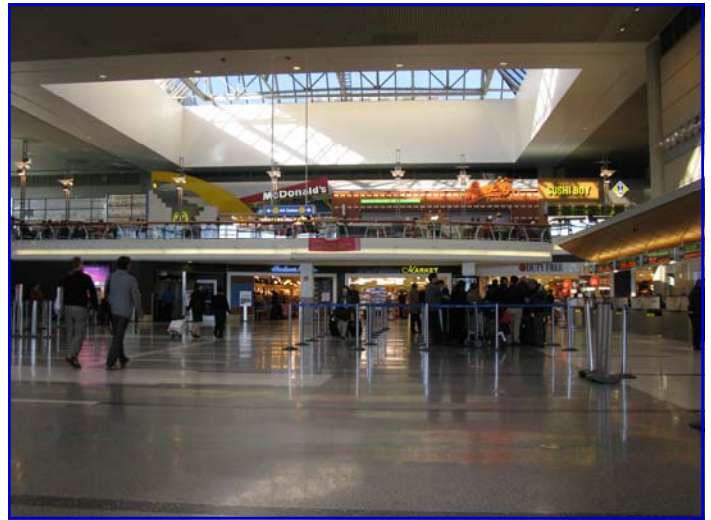
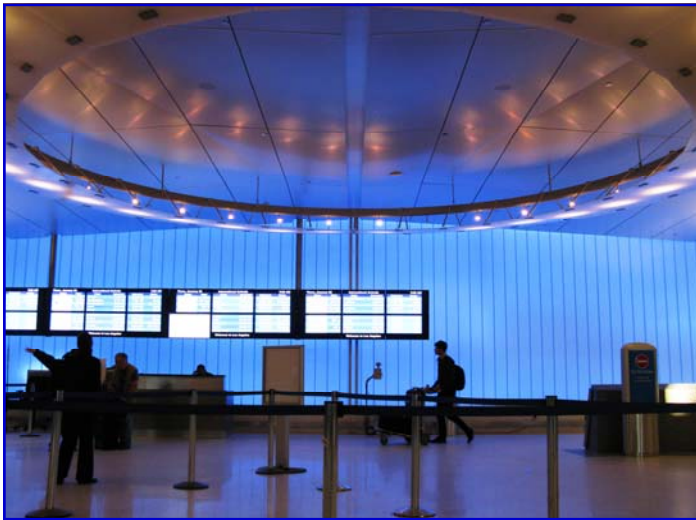
North Interline Baggage Drop

Both of the inbound Interline Baggage Drops are now operational, allowing APS Interline to input the bags directly into the new TBIT Sort Pier BHS system. This feature will free up the east and west roadways thru

the interstitial area and vastly reduce the amount of baggage sitting on the floor at the ends of the aisles. We continue to work with SITA and the airlines to get the BSM / BTM transfer messages for baggage sortation.

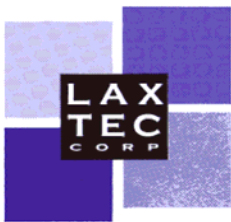


TBIT WOW Program Construction
