COMMENTS:

Overall, Concession sales are down 82.1% (\$157.56m). In-Terminal Concession sales are down 85.5% (\$78.8m), compared to the 78.2% enplaned passenger (PAX) decline during the same period.

Advertising sales are down 59.5% (\$2.26m).

Duty Free sales are down 100% (\$22.7m). All the Duty-Free stores are closed as the Int' PAX numbers are down 90.2% YoY due to impact of COVID-19.

F & B sales are down 86.2% (\$30.86m), which is worse than the decrease in PAX of 78.2%. Sales in TCM terminals are down 87.7% (\$19.18m), while TCM terminals PAX are down 82%. Sales in Non-TCM terminals are down 83.7% (\$11.68m), while the PAX in Non-TCM terminals are down 72.4%.

Retail sales are down 76.9% (\$14.95m). TCM terminals sales are down 81.9% (\$10.85m) compared to the 82% decrease in TCM terminals PAX numbers. Sales in Non-TCM terminals are down 66.3% (\$4.09m), while PAX numbers in Non-TCM terminals are down 72.4%.

Gross sales from Services are down 77.2% (\$8.03m).

RAC sales are down 79% (\$78.75m).
