WHAT'S NEW AT THE LAX SECURITY BADGE OFFICE



I. TENANT SUITE PROGRAM

Effective April 1, 2019, LAWA's Emergency Management Division will implement a mandatory emergency preparedness training program for all badged employees of all airlines, contractors or stakeholders at LAX.

II. AIRCRAFT FUELER ICON

Effective April 1. 2019, LAWA's Airport

Operations Division will be rolling out a new Aircraft Fueling Icon for all airport tenants who fuel aircraft at LAX.

- The Aircraft Fueling Icon is a requirement of the FAA, Federal Aviation Regulations (FAR) Part 139.321. which stipulates that related training on aircraft fueling safety must occur every 24 consecutive calendar months.
- Upon completion of the Aircraft Fueling Icon training administered by LAWA Airport Operations Division, qualified badge applicants will receive a stamp of approval on their badge application with the training expiration date.

III. PROHIBITED ITEM TRAIN-ING

(Concessionaires/Terminal ID & SIDA Badge Holders who work for those companies in the Sterile Areas at LAX)

Effective **February 1, 2019**, the Los Angeles World Airports required that all Terminal ID company **applicants, who work in the Sterile Areas of the Airport** and are applying for a new, renewing or replacing a damaged, lost, or stolen **Terminal Identification Card** or **Security Identification Badge**, must attend a mandatory **Prohibited Items Training and or obtain the approval stamp**, prior to being badged.

 Authorized Signers should email alertvaau@lawa.org to enroll employees for the Prohibited Items Training. Fingerprint approval from the Badge Office website is <u>required</u> for the enrollment for all new applicants.

IV. CERTIFIED SERVICE PRO-VIDER PROGRAM (CSPP)

LAWA Board of Airport Commissioners has recently extended the Certified Service Provider License Agreements (CSPLA) for over 75 companies at LAX. This means that the Security Badge Office will be renewing approximately 15,000 badges for the affected companies before June 30, 2019.

- We are working on a **badge**renewal strategy for companies who have **CSPLAs.**
- We strongly encourage the Authorized Signers of CSPLA companies to ensure that their companies are in good-standing with the Badge Office and the Airfield Permits Division so that there will be no unnecessary delays in the badge renewal process.
