



TERMINALS 2 & 3 MODERIZATION PROJECT

What is the LAX Terminals 2 and 3 Modernization Project?

Since the late 1980's when Terminals 2 and 3 (T2 and T3) were constructed, there have been many changes in the way an airport terminal has to operate both in terms of passenger and bag screening, the way airlines process passengers at ticketing and baggage claim, as well as changes in aircraft fleet mix and flexibility of passenger gate processes Efforts to accommodate these and federal positions. new security requirements within aging infrastructure have resulted in a reduced level of service for our passengers. The proposed project would:

- Comply with Transportation Security Administration and U.S. Customs and Border Protection requirements for enhanced security and customs screening to improve safety and security;
- Modernize existing T2 and T3 in order to revitalize passenger level of service and amenities within the terminals, similar to other terminals within the CTA;
- Coordinate improvements to the aircraft apron areas (i.e., aircraft parking positions, passenger boarding bridge, aircraft fueling system hydrant, ground support equipment parking locations) to be compatible with proposed T2 and T3 improvements;
- Enhance the interior and exterior of the terminals to benefit the overall appearance of the CTA and upgrade building systems (e.g., mechanical, plumbing, electrical, IT, etc.);
- Provide a secure connector between T2 and T3 to allow passengers to connect between terminals and only go through security once; and
- Renovate to new passenger and baggage processing facilities maximizing operational efficiencies.

PROJECT COMPONENTS

- Upgrading T2 Concourse: Additional floor area and reconfiguring gates.
- Upgrading T3 Concourse: Additional concourse area, new tower, and reconfiguring gates.
- Upgrading passenger and baggage process facilities.
- > New secure connector between T2 and T3.
- Apron improvements: Relocation of fuel pits, resurfacing/restriping apron area and aircraft-parking layout plan.
- Sustainability improvements (i.e., energy efficient building systems).

All projects at LAX require local approval and environmental clearance, as dictated by the California Environmental Quality Act (CEQA). In order to fulfill CEQA requirements, LAWA has prepared a Draft Environmental Impact Report (Draft EIR) for the LAX Terminals 2 and 3 Modernization Project.
