## CALL TO ORDER

The meeting was called to order by Chair Luciano Nocera at 7:03 p.m.

## 1. WELCOME/INTRODUCTIONS

Roll call was taken by Ms. Carcel. Ten of the 14 Committee Members were present: William Cumming (Marina Del Rey); Jim Evans (Westchester/Playa Del Rey); Guido Fernandez (Hawthorne); new Member Beth Hyatt (Culver City); Jonathan Loewenberg (Westchester/Playa Del Rey); David Mannix (Westchester/Playa Del Rey); Adam Moore (Culver City); Luciano Nocera (Culver City) (Chair); Sergio Paz (Lennox); and Angie Reyes English (Hawthorne). Katrina Manning (Hawthorne) arrived later. Absent: Henry Brown (Inglewood); Lance Giroux (El Segundo); Carol Pirsztuk (El Segundo); and Jim Withrow (Inglewood) (all unexcused). Carl Jacobson (El Segundo) and Kevin Klowden (Culver City) had been removed by their appointing authorities. Per the LAX AAC Bylaws, seven Members representing the majority of the communities shall constitute a quorum, therefore, a quorum was present.

A Motion to elect Angie Reyes English as Vice-Chair was made by Ms. Manning, seconded by Mr. Moore. The Motion was unanimously **APPROVED** by all 11 voters present; zero opposed; zero abstained.

 <u>LAWA REPORT</u> – NICOLE CARCEL, DIRECTOR OF COMMUNITY RELATIONS Nicole Carcel, LAWA Director of Community Relations, [424-646-8102, NCarcel@LAWA.org], reported as follows.

"Thank you to our extraordinary Airport Police Department for joining the Palisades Fire mutual aid effort. Officers have been deployed to ensure there is effective coordination and collaboration with partner agencies. Our team has also deployed our mobile command post to assist in efforts. In addition, I would like to thank the air resource efforts including the amazing pilots and crew who support the Supper Scoopers that operate out of Van Nuys Airport (VNY). The team from Canada has been with us all season and thankfully extended their departure from early December due to the lack of rain in the region.

On Dec. 14, LAWA hosted its annual Santa Fly-In events at LAX and VNY, where children and families gathered for up-close views of aircraft, holiday-themed activities, and a chance to meet and greet Santa. Over 1,200 community members attended the two events and supported toy donation drives benefiting the Westchester and Mid Valley Family YMCAs. The activities at each location included tours of various aircraft and the airfield, engagement with therapy dogs from the LAX PUPs (Pets Unstressing Passengers) Program, airplane ornament decorating, 360-degree and print-out photo booths, and story time with Santa. Kris Kringle made his highly anticipated grand entrance at LAX and VNY by landing on the airfield with his reindeer and elves in a Cessna 182. At the LAX event, which took place on the airfield next to the Flight Path Museum & Learning Center, attendees were able to climb inside a DHL Cargo plane and a commercial plane provided by Alaska Airlines. At VNY, a helicopter provided by Helinet, and aircraft provided by Clay Lacy Aviation, the Condor Squadron, LA Flight Academy and Corsair were on display.

She will lead a team of terminal operations leaders; guest experience professionals and strategic project teams and oversee all experiential initiatives.

**Westchester Parents Nursery School Visits LAX** — On Jan. 29, the Westchester Parents Nursery School joined the Community Relations team for an airfield tour of LAX and an Airport Police K-9 demonstration. The young visitors enjoyed watching planes take off and land, while learning all about how the airport works. Officer Torres and his K-9 partner, Zero, helped make the field trip extra special.

Aerial Survey of LAX Northside — As part of the Maintenance Yard Relocation project, LAWA is coordinating an Aerial Survey, which will take place the week of February 17th. The survey will be conducted with a Cessna aircraft flying over the Northside area at 2500 ft. The flyover is expected to occur mid-day and will take about 1 minute.

**Terminal 2: Arrivals Graphic Installation** — New graphics are landing at Terminal 2! This week, crews will continue work to install graphics in the Arrivals Hall just east of Bag Claim to help welcome guests to the City of Angels. The graphics are inspired by the diverse landscape of all that Los Angeles has to offer, from iconic LAX sights such as the Theme Building to the Hollywood Sign, Santa Monica Pier and more. It blends our city's love of film, entertainment and of course the beach over a backdrop of warm oranges and yellows to mimic the unbeatable West Coast sunset.
