

ATMP CAST-IN-DRILLED-HOLE TEST PILE PROGRAM

To facilitate work for the Airfield and Terminal Modernization Project (ATMP), please be advised that Cast-In-Drilled-Hole (CIDH) test piles will be constructed and tested at three sites during June and July 2025. Anticipated impacts associated with the ATMP CIDH test pile program include increased noise levels and construction vehicles hauling excavated soils between sites during the construction phase; there will be no impact to the public during testing. There are no scheduled impacts to vehicular or pedestrian traffic or access beyond slight delays when soil is being hauled. Please use caution when traveling near construction areas.



ATSAC HUB RELOCATION: LAWA + LADOT

To facilitate the relocation of the Advanced Transportation System and Coordination (ATSAC) Hub at LAX, please be advised that lane restrictions will be in place on Century Boulevard, Sepulveda Boulevard and Vicksburg Avenue beginning mid-June 2025 with construction of the new hub scheduled to begin early July. The existing hub located in the old Airport Police Headquarters must be demolished to facilitate work for the Airfield and Terminal Modernization Project and other construction at LAX.



Did you know: The ATSAC Hub supports traffic signals throughout the LAX campus and surrounding roadways and is owned and operated by LADOT, with LAWA facilitating the relocation of the hub.




LANE IMPACTS AT AVIATION BLVD & 104TH ST

To facilitate in-line inspection of pipelines, SoCalGas has restricted a portion of Aviation Blvd at 104th St to one northbound and one southbound open lane and implemented a full closure of a portion of 104th St east of Aviation Blvd. This project and associated lane impacts are scheduled to be completed by Friday, July 25. Access to 104th Street west of Aviation Boulevard and the CNG Station at the southeast corner of intersection will be maintained at all times; please plan ahead for potential delays.

While this work is being performed by a third-party, LAX Airport will continue to monitor for coordination and access needs.

MAY 2025: 24/7 CTA LANE RESTRICTIONS


Here is a collective snapshot of scheduled 24/7 lane restrictions for CTA Departures and Arrivals Level Roadways for the month of May 2025.

This map only reflects 24/7 continuous lane closures in the CTA; nightly lane / sidewalk restrictions may be in place to facilitate construction activities.

Traffic around the Central Terminal Area will be maintained at all times, as well as access to passenger pick-up and drop-off and ingress to / egress from parking structures.

Motorists should plan ahead for potential delays and use caution when traveling near construction areas.
