The Van Nuys Airport Fly Friendly - Quiet Departure Program asks that operators of jet aircraft use manufacturer's or NBAA quiet departure procedures to reduce departure noise. This voluntary program sets target noise levels for each aircraft type. Limiting departure noise to the target level may be impossible under some circumstances. Therefore, an item in the list above showing departures exceeding the target noise level does not necessarily indicate a lack of compliance with the program.

* The QDP is on hold until the taxiway crossing rehabilitation project is completed and full-length departure from runway 16R resume. The taxiway project started on February 11, 2025 and is expected to be completed on Jun 26, 2025.
